Introduction:

The 46th Civil Support Team (WMD) is a high-priority response unit supporting civil authorities in responding to a weapons of mass destruction (WMD) or other hazardous incident. The CST provides assessment of the damage, consultation on logistics, medical, CBRN defense, and transmission of the situation to higher headquarters. The CST is operationally-ready 24 hours a day, 7 days a week, for both real-world mission requirements and training/exercises. The team may work under hazardous and potentially life threatening conditions. **All CST Team members will potentially train/work with live chemical, biological, and radiological agents/releases as a result of training and/or operations.**

DUTIES & RESPONSIBILITIES:

POSITION DESCRIPTION: Responsible for tracking and ensuring all training requirements are met for Medical section personnel. Serves as Deputy Quality Manager for ISO-17025 program. Acts as a resource for the 46TH Civil Support Team Commander on the medical administrative aspects of a response to a hazardous event. Identifies the requirements for victim transportation including the number and types of vehicles needed. Provides advice on disbursement of casualties, based on location of the needed bed capacity and capabilities of the healthcare facility. Acts as a resource for the Incident Commander, local healthcare facilities and other DoD response elements on procedures required to control access and prevent further spread of contamination when requested. Provides advice on expansion of current health care facilities to accommodate the number of victims. Recommends relocation of patients from contaminated or destroyed medical care facilities. Advises the 46TH Civil Support Team Commander on the release of medical information to the public. Obtains medical intelligence information and shares with appropriate agencies. Determines the formal reporting of hazard and victim information to the appropriate agencies. Coordinates with civilian and federal healthcare facilities to identify their need for follow-on support. When needed, facilitates follow-on medical support for the Incident Commander. Performs other military duties as required by mission. If not already 41A qualified the successful applicant must meet eligibility requirements based on current Air National Guard Medical Service Corp Accession Guidance with an effective date of 1 October 2015.

Special Requirements: This position requires an above average amount of TDY due to high operational tempo of the 46TH Civil Support Team (WMD). Because of the physical demands, all members must be in physical condition. Applicant must possess or be able to attain, and maintain, a Secret Security Clearance.

Additional Requirements for ANG AGR WMD-CST Personnel:

1. All WMD-CST members work in various chemical protective clothing, such as OSHA Level A Personal Protective Equipment (PPE) fully-encapsulated chemical suits with self-contained breathing apparatus. Members will be required to use respirators for duties that will vary from light to heavy, and may include security, rescue, and escape. This may occur under humid or cold conditions, and could exceed 4 hours per day.
2. Must meet the physical qualifications outlined in AFI 48-123, as appropriate. Must comply with the military duty eligibility requirements IAW ANGI 36-101. Knowledge is mandatory of: Air Force health services management; hospital administration and practice; contractual and accounting fundamentals; quality management; human resource management; and biometrics.
3. Must be able to work in PPE carrying a minimum of 80 lbs.
4. Selected individual must pass physical examination for Level A PPE IAW OSHA requirements and 29 CFR 1910.134(B) (10) before being accepted into the AGR program. This includes OSHA Respirator Medical Evaluation Questionnaire, medical evaluation for respirator clearance to include pulmonary function test and ALNG Respirator Clearance.
5. The Civil Support Skills Course (CSSC) must be successfully completed within 12 months of assignment. Also due to critical special training and mission requirements, personnel assigned to WMD-CST will commit to serve a three (3)-year stabilized tour that starts upon completion of Civil Support Skills Course (CSSC).
6. **Position is not considered a Career Status AGR. AGR orders will not exceed 6 years.**
7. All WMD (CST) members must live within 60 minutes of assigned duty station after assignment.

8. All WMD (CST) members will be on-call 24-hours a day, 365 days a year.
9. All WMD (CST) members will be exposed to live chemical warfare agents and may be exposed to biological agents and radiological releases as a result of training or operations.
10. This position requires extensive travel and training away from home station.
11. Must have a current state driver's license.
12. Must receive Smallpox and Anthrax vaccinations.
13. Must complete Department of Defense Hazardous Materials Technician certification, and maintain annual proficiency while assigned to the WMD-CST.
