SUBJECT: Army National Guard (ARNG) Title 10 (T10) Active Guard Reserve (AGR) One Time Occasional Tour (OTOT) Announcement Assured Position Navigation and Timing (APNT) Cross Functional Team (CFT) Senior Service Liaison/Officer, Redstone Army Arsenal, Huntsville, AL.

1. References:

a. AR 135-18, The Active Guard Reserve (AGR) Program, 11 October 2019.

b. ARNG-HRH Memorandum, 13 June 2018, subject: Title 10 (T10) Army National Guard Active Guard Reserve Life Cycle Management Strategy and Plan (ARNG-HRH Policy Memorandum #18-020).

2. The ARNG is seeking applications from highly qualified officers to serve as the ARNG Senior Service Liaison /Officer to the APNT CFT. The anticipated start date is as soon as possible.

3. Eligibility. Current T10 Active Guard Reserve (AGR), T32 AGR and Traditional Majors and Lieutenant Colonels. Officers with 15 or more years of Active Federal Service (AFS) will require a waiver, or must be career status AGR to be eligible to apply. T32 Traditional officers who achieve 18 years AFS on the OTOT, with an approved waiver, will have the option to have their orders extended to the completion of 20 years AFS. These officers will not be considered part of the T10 AGR program. Upon completion of 20 years AFS, when applicable, the officer will have the option to retire, or return to previous duty status.

4. This is an accompanied Permanent Change of Station (PCS) tour. The tour length is two years and upon completion of the tour the officer will be separated from the T10 AGR program and will return to his/her state for continued service. The selected officer will serve under the authority of Title 10 USC, Section 12301(d) IAW 12310(a). The selected officer will be processed as outlined below dependent upon their current duty status.

a. T10 AGR Officer – will remain in the T10 AGR program and will receive Permanent Change in Station (PCS) or reassignment orders.

b. T32 AGR Officer – will be accessed into the T10 AGR program for a duration of two years and will serve on a One Time Occasional Tour (OTOT). Upon completion of

the tour, the officer will be separated from the T10 AGR program and returned to the T32 program or to a traditional duty status.

c. Traditional (M-Day) Officer – will be accessed into the T10 AGR program for a duration of two years and will serve on a One Time Occasional Tour (OTOT). Upon completion of the tour, the officer will be separated from the T10 AGR program and returned to traditional duty status.

5. Brief Duty Description: Serves as the senior service officer and liaison for the ARNG to the APNT CFT. The LNO provides advice and expertise to their respective agencies regarding the integration and utilization of ARNG personnel and resources to meet the CFT's requirements. Monitors and coordinates the execution of ARNG Soldiers participation in CFT activities. Assists with policy, planning, programming, management, evaluation, oversight of positioning navigation and timing systems development, acquisition, testing, and fielding. Provides real-time support, weekly update and special updates as needed to the NGB ARNG Director and his staff.

6. Pre-requisites:

a. Applicants must meet AGR eligibility requirements IAW AR 135-18.

b. Grade: DA Select O4/O5 (MAJ/LTC).

c. Branch Requirement: 01A Immaterial.

d. Civilian Education: Master's Degree preferred.

e. Military Education: CGSC graduate.

f. Security Clearance: Must have a current Secret Security Clearance at the time of application.

g. Security Clearance: Must have a current Secret Security Clearance at the time of application.

a. T10 AGR Officer – T10 officers applying for consideration must submit a DA Form 4187 signed by their respective OPR/G-Staff primary, to the POC in paragraph 8 no later than **22 March 2021**.

- (9) Individual Medical Readiness (IMR) Record printout. Physical exam and/or AMC/PHA within 15 months, and HIV within two years.
- (10) NGB Form 23b, RPAM.
- (11) TAG Release Memorandum.
- (12) Security Clearance Verification JPAS Statement or Memorandum verified by State Security Manager.
- (13) DD Form 1172-2, DEERS Enrollment signed by certified official.
