**Duty Position Job Description/Criteria:**

Serves as the Individual Weapons Qualification branch chief of the ALNG Lethality Group. Responsible for providing Commanders and Soldiers with operational knowledge and expertise in support of individual weapons qualification training, doctrine, and utilization strategy. Assist with coordinating training using TADSS equipment. Operates various simulators, simulations, and devices assigned to the ALNG Lethality Group. Provides knowledge and expertise to individual unit personnel. Serves as a Subject Matter Expert for TADSS device trainers, calibration, weapons, and various components used in the instruction of trainers. Research data from a variety of sources to provide information on doctrine and utilization strategy to applicable trainers based upon TRADOC training guidance. Develops, reviews, and recommends training plans, Program of Instruction (POI), etc., to ensure individuals receive training in the most up-to-date regulatory procedures conducted by Instructor/Operator (I/O) personnel. Assist with the management of the TADSS Certification Training Program for, but not limited to, the following equipment:

- Engagement Skills Trainer (EST 2000 II)
- Individual Gunnery Trainer (IGT)
- Virtual Combat Operations Trainer (VCOT)
- Virtual Battle Station (VBS)

Assists newly assigned unit instructors to improve instructional competence. Prepares for assigned classes by ensuring instructional materials, training aids, and systems are present and are operational. Monitors and observes students during practical exercises and provides assistance as required. Assists the State Master Gunner in developing individual and collective training events. Presents technical instruction to military personnel. Instruction includes detailed explanation, demonstration, and guidance on practical exercises that provides each Soldier with the knowledge required to perform the I/O duties. Evaluates performance and provides special assistance to students requiring special or additional training. Supervises and operates training devices and simulators installs and sets up simulators and performs daily preoperational readiness checks. Reports faulty equipment to the Training Support NCO and coordinates for turn-in and/or maintenance of the equipment. Conducts quality assurance checks per respective SOP. Explains and demonstrates weapon safety, firing positions, fundamentals, and techniques of marksmanship. Is familiar with and can explain and administer range safety regulations and standards. Assists unit's with scoring field firing results to include target detection, range estimation, firing positions, and other marksmanship principles. Basic computer

skills, knowledge of Microsoft Word, Excel, Adobe PDF, and PowerPoint are required. Submits and maintain training reports. Ability to read, interpret, and implement technical manuals, publications, and regulations. Have the ability to coordinate with unit trainers to plan, organize, and complete individual weapons qualification requirements. Ability to work well under pressure, be a self-starter, demonstrate reliability and responsibility in securing facilities and assigned equipment.
