The individual will provide response for any system monitoring failures, compound breaches, military personnel problems, SIRs and CCIRs. During Domestic Operations (DOMOPS), the individual functions as the JFHQ-AL JOC Message Center NCO. Individual must be able to successfully complete all assigned duties with minimal supervision. Performs all other duties as assigned. **The duty hours for this position are a 12-hour shift and includes nights, weekends, and holidays.
