Open to current Alabama Army National Guard AGR Service Members in the grades of O1-O3 who are currently qualified in the 36A00 AOC or willing to become qualified within a year.

**Duty Position Job Description/Criteria:**

Position requires service member is DMOSQ as 36A00 or willing to become qualified within a year. Additionally, applicants must be Airborne qualified or able to become qualified within a year. Service Member would be responsible for managing financial resources to ensure mission readiness, accountability, and compliance with federal regulations. Officer will serve as the primary staff officer for managing funds, manpower, and other resources to support operations. They will plan, develop, justify, analyze, and execute programs and budgets; advise on programming, budgeting, finance, and accounting matters while examining, controlling, and auditing all finance and accounting systems. They will prepare and distribute financial reports and statements to provide commanders and staff with information on fund status, budget performance, and management. Soldiers will direct and coordinate financial management functions while acting as the commander's advisor on all financial management issues.
