SUBJECT: 135th ESC Inspector General NCO Statewide Vacancy Announcement

2. This is a “**STATEWIDE**” announcement to fill an Inspector General NCO vacancy within 135th Expeditionary Sustainment Command Inspector General. The announcement is open to all eligible M-day Soldiers currently in the Pay grade/Rank of E7/SFC or promotable E6/SSG on current standing promotion list. Packets that do not meet the rank requirements will not be actioned.
